Here Rockefeller has stated that the media is keeping quiet about their plans for world government.

When it comes to world government there are many other players than the Rockefellers like the Rothschilds and the black nobility, particular families of the ancient bloodlines going back to Rome and even Babylon. But here we focus on the Rockefellers to keep things simple, as this is an introduction to conspiracy facts and I don't want you to be overloaded with information; this is merely a place to start.

John D. Rockefeller's father, William Rockefeller was known to be a liar and cheat who called himself a "celebrated cancer specialist" when he sold Rock Oil for \$25 a bottle claiming it would cure all cancers. This oil was merely a mixture of laxatives and petroleum. When discovered to be a fraud, Rockefeller would simply travel to the next town to dupe a fresh new crowd. It appears that this is where the phrase "selling snake oil" came from...

His son John D. Rockefeller became unimaginably wealthy from Standard Oil in the late 19th century.

This monopoly received great criticism from those living in America. The Rockefellers were even called robber barons taking over the economy to the public's detriment. To deflect their poor reputation, the Rockefellers used a new ploy to manufacture consent, to continue to gain more power over the people under the heading of philanthropy and a well-funded PR campaign.

The Rockefeller syndicate took over education, media, medicine, and agriculture, partnering with chemical monopolies and Big Pharma connected to the banking system and governments worldwide through hundreds if not thousands of foundations, trusts, and think-tanks that supposedly act in the "public good." This is a lie.

Like William Rockefeller's snake oil, the Rockefeller empire would seek to use petro-chemically derived compounds in medicine called pharmaceuticals, even though these compounds are found to be harmful.

An article entitled *A Look Into the Petrochemical Industry* states that "...since petrochemicals can be absorbed through the skin or might be ingested, they can accumulate in human tissues and organs such as the brain and liver and can cause brain, nerve and liver damage, birth defects, cancer, asthma, hormonal disorders and allergies."

The book *Rockefeller Medicine Men and Capitalism* goes into how Rockefeller and cohorts hijacked the medical system. It begins with:

"The crisis in today's health care system is deeply rooted in the interwoven history of modern medicine and corporate capitalism. The major groups and forces that shaped the medical system sowed the seeds of the crisis we now face. The medical profession and other medical interest groups each tried to make medicine serve their own narrow economic and social interests."

The conflict of interest is clear that the medical institution based on corporatism requires a flawed science to be profitable... as true science would cure and heal all things with natural remedies or technologies aligned to natural laws.

In 1910 Abraham Flexner published a report called *Medical Education in the United States and Canada*, sponsored by the Rockefeller Foundation and the Carnegie Foundation, that called for the standardization of medical education, which led Congress to declare the American Medical Association as the only body with the right to grant medical school licenses in the United States.

Medicine would be solely allopathic, about toxic drugs, vaccines, chemotherapy, and radiation, about indefinitely treating symptoms and never getting to causal factors. Nutrition, holistic medicine, natural healing, and natural immunity would be considered quackery by this medical monopoly, replacing the humanitarian drive for healing with the drive for profits and control.

For example, Merck & Co's arthritis drug Vioxx killed 60,000 people, before it was removed off the shelf. The company only received a misdemeanor and 321 million dollar settlement.

Notice how the caduceus, a hermetic symbol has two snakes on the rod, which represent holistic consciousness, mental gender, and the integration of the left and right brain hemisphere. This is used as a symbol of medicine. But notice how the American Medical Association, only has one snake, as well as the World Health Organization. This is a deliberate corruption of the symbol, as modern medicine is left-brain biased which is what makes it harmful.

(Left-brain medicine is just as harmful, but we wouldn't be productive slaves with that imbalance.)

The Rockefeller's founded the American Cancer Society in 1913, one of the wealthiest non-profit institutions today, which is not about curing cancer but about suppressing its origin, destroying holistic education, and selling expensive drugs for treatment to make Big Pharma rich.

Samuel Epstein, Professor for Environmental and Occupational Medicine at the University of Illinois wrote a paper on the ACS. He reports that the Foundation's board consists of corporate executives from the pharmaceutical, investment, banking, and media industry.

"Giant corporations, which profited handsomely while they polluted air, water, the workplace, and food with a wide range of carcinogens, remain greatly comforted by the silence of the ACS. This silence reflected a complex of mindsets fixated on diagnosis, treatment, and basic genetic research, together with ignorance, indifference, and even hostility to prevention. These mindsets are also coupled with major conflicts of interest.

Also saying:

Not surprisingly, the incidence of cancer over past decades has escalated, approximately parallel to its increased funding," and that "the verdict is unassailable. The ACS bears a major decade's long responsibility for losing the winnable war against cancer."

ACS has received contributions in excess of \$100,000 from a wide range of "Exalibur Donors."

Epstein has written many books such as *Cancer-Gate*, *Medicine on Trial*, and *Criminal Indifference of the FDA to Cancer Prevention: An Anthology of Citizen Petitions, Newspaper Articles, Press Releases, and Blogs 1994-2011*.

Like the American Cancer Association, the FDA was also founded in 1913 and started as a chemical company but changed its name to conceal itself. This organization provides legal immunity for companies to put toxic chemicals in their products.

The cause of cancer is found in these toxic pollutants found in the water, air, food, and workplace, and household, cosmetic, and personal care products.

If you didn't know, we are discussing the topic of bioterrorism. Bioterrorism is defined as the deliberate release of viruses, bacteria, toxins, or other harmful agents to cause illness or death in people, animals, or plants.

And we will soon investigate how getting sick, such as getting colds and cases of the flu are actually an immune response from the body to purge itself of a build-up of these toxins. That's why we don't have cures for colds and flus—because those symptoms are an attempt from our bodies to return to health.

But now Big Pharma wants to call a cold a disease to proscribe medicine that actually negatively suppresses our natural immune system.

Glyphosate is a dangerous carcinogenic pesticide in Monsanto's Roundup that its GMO seeds are designed to resist. Since the creation of GMOs has been the increased use of pesticides.

Toxic pesticides have contaminated nearly all non-organic foods. A growing number of studies show that certain pesticides can cause cancer, Parkinson's, and Alzheimer's.

Monsanto, along with a handful of other giant corporations have taken over the food supply with genetically modified organisms that are also bad for human health in addition to pesticides. In the genetic engineering process, allergens and toxins are added to the food; furthermore, there are toxic chemical substances found in organisms that aren't naturally produced like xenobiotics. GMOs have caused gluten disorders, impaired digestion, and damage to the intestinal wall.

A study led by Gilles-Eric Seralini linked GMO corn to rat tumors, the study was retracted by the publisher against the author's objections, they claim the retraction was made by a Monsanto lobbyist and was a "public-health scandal."

Monsanto started as a chemical company in 1901.

In 1985 Monsanto acquired the pharmaceutical company G.D. Searle & Co that produced the female birth control and got aspartame or nutrasweet—a neurotoxin approved by the FDA.

In 1999 Pharmacia and Upjohn merged with Monsanto. One of the largest pharmaceutical companies Bayer bought out Monsanto in 2018. Remember Bayer, as it is one of the pharmaceutical companies behind Nazi Germany... which we will get to.

Big agriculture, biotech, and Big Pharma have been integrated as their interests unite. The problems caused by GMOs and pesticides create the solutions in symptom-suppressing drugs, profiting from both sides of a dialectic.

Problem-reaction-solution is the methodology of the power elites, who pretend to be philanthropic when they have created the problem.

In Dr. Gary Null's book *Death By Medicine* (2010) he states about our modern medical system:

“This fully referenced book reveals a number of startling facts: The number of people having in-hospital, adverse reactions to prescribed drugs annually: approximately 2.2 million, the number of unnecessary and/or inappropriate antibiotics prescribed annually: approximately 45 million per year, the number of unnecessary medical and surgical procedures performed each year 7.5 million, the number of people unnecessarily hospitalized each year 8.9 million... with the most stunning statistic being that nearly 800,000 people per year die from conventional medicine. He concludes that “it is evident that the American medical system is the leading cause of death and injury in the United States.”

The Rockefeller’s monopoly on medicine would become global with the implementation of the World Health Organization, a branch of the United Nations that would destroy natural health approaches worldwide to be replaced with toxic patented drugs that would cause disease and death in genocidal proportions. One major way is through the vaccine industry.

Why would the Rockefellers and other wealthy/powerful families want to poison the population?

The ruling class, in general, adheres to the ideology of eugenics, the belief that a superior class should maintain population control and reduction (depopulation) of the slave class through genocide, “culling the masses,” and “weeding out the weak.” (Rockefeller clip)

Henry Kissinger’s report NSSM 200 in 1974 is about depopulation of the third world, saying, “There is no single approach which will solve the population problem. The complex social and economic factors involved call for a comprehensive strategy... at the same time actions and programs must be tailored to specific countries and groups.

In the 1967 government’s *Iron Mountain Report*, it calls for “a comprehensive program for applied eugenics.” The report is about how perpetual war is necessary for a governed society, but that new means of war will need to be used in times of peace.

“The war system not only has been essential to the existence of nations s independent political entities, but has been equally indispensable to their stable internal political structure. Without it, no government has ever been able to obtain acquiescence in its “legitimacy,” or right to rule its society.”

The basic authority of a modern state over its people resides in its war power.

“The war system makes the stable government of societies possible. It does this essentially by providing an external necessity for a society to accept political rule. In so doing, it establishes the basis for nationhood and the authority of government to control its constituents. What other institution or combination of programs might serve these functions in its place?”

It calls for the need to create “alternative enemies”

“Nevertheless, an effective political substitute for war would require “alternate enemies,” some of which might seem equally farfetched in the context of the current war system. It may be, for instance, that gross pollution of the environment can eventually replace the possibility of mass destruction by nuclear weapons as the principal apparent threat to the survival of the species. Poisoning of the air, and of the principal sources of food and water supply, is already well advanced, and at first glance would seem promising in this respect; it constitutes a threat that can be dealt with only through social organization and political power.”

“Another possible surrogate for the control of potential enemies of society is the reintroduction in some form consistent with modern technology and political processes, of slavery. Up until now this has been suggested only in fiction... It is entirely possible that the development of a sophisticated form of slavery may be an absolute prerequisite for social control in a world at peace.”

The report also calls for the creation of war group that would determine the “minimum and optimum levels of destruction of LIFE, PROPERTY, and NATURAL RESOURCES” prerequisite to the credibility of external threat essential to the political and motivational functions.”

The report also states that “The existence of an accepted external menace, then, is essential to social cohesiveness as well as to the acceptance of political authority. The menace must be believable, it must be of a magnitude consistent with the complexity of the society threatened, and it must appear, at least, to affect the entire society.”

“In general, the war system provides the basic motivation for primary social organization... the most important of these... is the individual psychological rationale for allegiance to a society and its values. Allegiance requires a cause; a cause requires an enemy.”

Looking a history, it will become evident that the new enemy of man would not only become global warming, but “viruses” and bioterrorism to enable militarized social control.

Today public health asserts that micro-organisms called viruses are the single cause fo disease; this is based on germ-theory, a theory perpetrated by politically-controlled science that has been disproven by many scientists, more of which we will explore towards the end of this series.

We have been told that viruses are the enemy of man, but what exactly is a virus?

In this Article: “How Viruses Work,” it states that “Unlike human cells or bacteria, viruses don’t contain the chemical machinery (enzymes) needed to carry out the chemical reactions for life. So, a virus must have a host cell (bacteria, plant or animal) in which to live and make more viruses. Outside of a host cell, viruses cannot function. For this reason, viruses tread the fine line that separates living things from nonliving things.”

But later the article states that “Because a virus is merely a set of genetic instructions surrounded by a protein coat, and because it does not carry out any biochemical reactions of its own, viruses can live for years or longer outside a host cell.” p.5

This is a contradiction.

No virus has been detected outside of cellular tissues as it is not a living organism.

Incorrectly viruses are perceived as randomly floating in the air ready to attack us.

But this natural object, we call a virus, having genetic instructions inside a protein shell, has never proven to be harmful to cells, infect them or cause illness as we shall see. There is more evidence that they are the body’s response to harm.

Left-brain science cannot see holistic principles such as origin and causality. The first question should be: if a virus can only exist in a cell then where do viruses come from? And we have answered our question, viruses can only be made by a cell.

The electron microscope found particles in blood serum entering and leaving human cells and they were instantly assumed that they were hijacking cells to reproduce, even though they were a billion times smaller than the cell. Viruses have been condemned as poison and nano-terrorists in our bodies.

From *Fear of the Invisible*:

“We have been taught to greatly fear viruses - and yet scientists have long known that these are fundamental parts of life, made by the millions by all healthy cells. “ p. XI

There is intelligence in nature and a virus would not spontaneously arise from within the cell for no reason.

The next holistic question would be, WHY do cells produce viruses or microbes that we call viruses? If we do not understand natural law than we might think cells are destructive and that they without any reason produce a product of their own demise.

But under Natural Law there would have to be some purpose in the body's creation of viruses.

In the 1960s Dr. Ryke Geerd Hamer from Germany created a holistic approach for curing cancer and demonstrated that microbes like bacteria and viruses do not harm the organism but instead play a supportive role during the healing process from diseases.

In 1983 scientists discovered exosomes, extracellular vesicles that contain protein, DNA, and RNA) secreted by cells. This description fits viruses so much many now consider them the same thing. James Hildreth, MD CEO of Meharry Medical College and former Professor at Johns Hopkins said, "the virus is fully an exosome in every sense of the word." More on this later.

By claiming that something our cells naturally produced *is* the cause of illness, the real causal factors for illness perpetrated by the eugenics-medical complex can be hidden.

In the book *The Molecular Vision of Life: Caltech, The Rockefeller Foundation, and the Rise of the New Biology*, author Lily E. Kay reveals how eugenics and social engineering has shaped the 20th-century sciences, which are not at all about the actual scientific method by applying pseudo-science towards the social control and domination of man.

The Iron Mountain report also discusses how all governmental science is based on warfare.

"The relationship of war to scientific research and discovery is more explicit. War is the principal motivational force for the development of science at every level, from the abstractly conceptual to the narrowly technological. Modern society places a high value on "pure" science, but it is historically inescapable that all the significant discoveries that have been made about the natural world have been inspired by the real or imaginary military necessities of their epochs. The consequences of the discoveries have indeed gone far afield, but war has always provided the basic incentive." p.44

There are two agendas at play here.

At the highest level, the multi-billion dollar chemical and pharmaceutical industries create illness and non-curing medicine for eugenics and population control, while at the lower levels the agenda is capital gain and corporatism. People at any level will do destructive things against their fellow man for money.

Money is how things get incentivized, but the elite families at the top of the banking system, like the Federal Reserve don't need money as they can make money out of nothing. Have you ever asked where does money come from and who makes it? The reason why the power elites want our money is not because it makes them rich as money is no obstacle to them but because it drains us and further enslaves us so that in addition to the debt-slavery of our labor, much of our earnings go to medical costs, the affliction of sickness on top of a pathological work schedule. This is truly evil!

A healthy people with the time to actually research what's going on in the world is their biggest threat.

Eugenics ideology was propagated in the early 20th century and there were US laws based on this elitist pseudo-science that included compulsory sterilization of people deemed a defect to the human gene pool.

Later adding sterilization agents to water and food would also be a eugenics method, as well as the propagation of abortion and the women's liberation movement by Rockefeller-funded Planned Parenthood and neo-feminism social-engineering. The gender war equals fewer children.

In his book *War Against the Weak: Eugenics and America's Campaign*, Edwin Black discusses how the Rockefeller Foundation helped create the German eugenics movement and even funded the program under Josef Mengele consisting of deadly experiments and torture on prisoners.

Rockefeller's Standard Oil partnered with the German chemical giant I.G. Farben to fuel Hitler's regime. I.G. Farben was a cartel of six chemical companies including Bayer, Hoeschst, and BASF—

which remain today. They tested pharmaceutical substances on concentration camp inmates.

In *The Rockefeller File*, Gary Allen wrote that “the alliance between Nazi Germany and the Rockefellers is truly shocking.”

As partners with I.G. Farben, they created thousands of deadly products including the poisonous gas used in the Nazi death camps, Zyklon B that killed over a million people.

After the Nuremberg Trials, the convicted directors of IG Farben were quickly set free to work in the broken-up IG Farben companies that are still today the Pharma Giants, Bayer, and BASF, while US government decided to not pursue the criminal investigation of Standard Oil.

Even worse, through the CIA's project paperclip in 1945, over 1600 Nazi scientists, engineers, and technicians were placed into key positions of the US government secret programs and the military-industrial complex.

The CIA was created not to provide intelligence to government to protect American people, but to serve the interests of the bankers and power elite that would use its monopoly on violence and militarized state to control, regress, coerce, and harm the people to maintain power over them.

The director of the CIA, Allen Dulles was also the lawyer for Standard Oil and IG Farben.

While history would have us place all blame on one man for Nazi Germany, the horrific acts perpetuated could not have been possible without the support of the people and their institutions, public health campaigns, and the biggest corporations of the world working in collusion. This war-machine depended on the US and other countries and was an international affair.

Erich Traub studied at the Rockefeller Institute for Medical Research and became the lab chief of the Nazi's leading bio-weapons facility on Riems Island working with Heinrich Himmler. He came to work at the U.S. Naval Medical Research Institute giving operational advice to the CIA and the US bioweapons lab. Taub along with his assistants investigated over 40 strains of infectious diseases.

Dr. Kurt Blome who had a longstanding interest in the “military use of carcinogenic substances” and cancer-causing viruses worked on Nazi bacteriological warfare projects, experimenting on concentration camp prisoners giving them bubonic plague vaccines and sarin gas. He was recruited by the U.S. Army Chemical Corps and advised the Pentagon on biological warfare.

Essentially, Nazi Germany's bioweapon program came to America and the US government would just like the Nazi's experiment on the public, except in more stealthy ways.

Under Franklin Roosevelt, the bioweapons lab at Fort Detrick Maryland was created in 1943 as described in the book *Cutting Edge: A History of Fort Detrick, Maryland*, a lab that was “cloaked in the deepest wartime secrecy, matched only by... the Manhattan Project for developing the Atomic Bomb.” “Biological, chemical, and mechanical means of protection were studied. Vaccines, toxoids, antibiotics, disinfectants, and antiseptics were evaluated.”

George W. Merck, a key member of the panel for Fort Detrick and advisor for FDR, was the owner of Merck pharmaceutical, a company that would create vaccines, and that would later create the polio vaccine with a cancer-causing agent called SV40. (More on that later)

The book *Reich of the Black Sun* by Joseph Farrell discusses the Nazi's secret report called Rotes Haus or Red House report written in 1944 in Strasbourg that connects Merck to the plans of the Fourth Reich.

“In the Spring of 1944, Merck and Company, Inc. received a large cash infusion from Martin Bormann... This at the time Merck's president George W. Merck, was advising President Roosevelt, and initiating strategies, America's biological weapons industry director. According to CBS News correspondent Paul Manning, the lion's share of the Nazi gold went to 750 corporations, largely including Merck, to secure a virtual monopoly over the world's chemical and pharmaceutical industries. This was done not only for German's economic recovery, but to assure the rise of “the

Fourth Reich...

Merck then along with Rockefeller partner I.G. Farben, received huge sums of money from the Nazi war chest to actualize Hitler's proclaimed 'vision of a thousand-year Third Reich (and) world empire. This was outlined with clarity in a document called "Neuordnung" or 'New Order,' that was accompanied by a letter of transmittal to the (Borman led) Ministry of Economics. 'Bury your treasure,' Hitler advised Bormann, 'for you will need it to begin a Fourth Reich.'

In 2009, former CDC chief Julie Gerberding became president of Merck's vaccine division. Big Pharma and the governmental agencies are in bed together.

Our hearing today will focus on the risk associated with the recent increase of domestic BSL-3 and BSL-4 labs. These BSL-3 and 4 labs are the facilities where research is conducted on highly infectious viruses and bacteria that can cause injury or death. Some of the world's most exotic and most dangerous diseases are handled at BSL-3 and 4 labs, including anthrax, foot-and-mouth disease and Ebola fever. The accidental or deliberate release of some of the biological agents handled at these labs could have catastrophic consequences. Yet, as we will hear from the Government Accountability Office, GAO, no single Government agency has the ultimate responsibility for ensuring the safety and securing of these high-containment

labs. However, GAO states there is a major expansion of the number of BSL laboratories is occurring both in United States and abroad but the full extent of that expansion is unknown....

What we do know is that the Federal Government has been funding the proliferation of these labs on an unprecedented scale. For the past 5 years, the NIH has spent more than \$1 billion on the construction of new BSL-3 and BSL-4 labs. Given the serious risk associated with these labs, we must ask if all these new labs are necessary. Has the NIH carefully assessed the need for these labs before writing checks to build them? Would we be better off expanding existing facilities rather than building dozens of new ones? When it comes to BSL-4 labs, which are the labs that deal with the most serious diseases for which there is no cure, should we significantly limit the number of labs so there are fewer chances for an accidental or intentional release of these most dangerous substances? Has the proliferation of these labs reached the point at which there are so many labs doing this research that you actually increase the chances of catastrophic release of a deadly disease?...

Federal regulations require reports only for incidents involving so-called select agents, a list of highly dangerous pathogens. But other dangerous biological pathogens are not on the select agent list, such as hantavirus, SARS and dengue fever. It appears that there is no Federal oversight of the possession, use or transfer of these dreaded diseases nor is there any requirement that the theft, loss or release of these agents will be reported to Federal officials.

According to the congressional testimony by Dr. Alan M. Pearson, Director of the Biological and Chemical Weapons Control Program at the Washington D.C.-based Center for Arms Control and non-Proliferation, "tens of billions of dollars have been appropriated for bioweapons research. He claims there are 600 facilities at BSL- 3, and 12 at BSL-4 and some of these facilities are under construction and when completed will have 150,000 square ft of space.

While earlier we discussed how endogenous viruses, viruses made by our body (or what may be exosomes) have a positive biological purpose that we shall explore later, now we turn to the idea of weaponizing viruses or some kind of microbe through cross-species injections and genetic alterations.

Going back to the bioweapons lab in Fort Detrick... supposedly Nixon shut down offensive bioweapons operations so the facility was then run by the National Cancer Institute for the new "war on cancer." "Another interesting issue to contemplate is the Defense Department's New Policy on non-lethal weapon systems, where "adversaries" and "enemies" have been more broadly defined, as here the use of such systems against American citizens.

Herman Schwan, mentioned in the book, is recognized as the "founding father of biomedical engineering," and he served the Nazi's Third Reich at the Max Plank Institute, studying the effects of electricity and non-ionizing electromagnetic fields on cellular processes and their health hazards. The most covert method of bioterrorism is weaponizing micro-organisms. While micro-organisms that are naturally produced by the body have never been proven to cause disease, foreign micro-organisms that have been modified, genetically engineered, or come from cross-species can be a trigger for disease as we shall see.

So making the virus the new enemy of man is merely a half-truth, as there are "novel" viruses, created by man, that are dangerous. Because most people are in the dark about weaponized viruses, they have false beliefs about nature and our bodies and the function of natural viruses in healthy immunity. This is another tool to turn man against himself in the ignorance of his physical

form, as well as getting man to believe that nature is the enemy.

All types of bioterrorism work synergistically to harm man, as the cause of an illness is usually from multiple factors.

One of the greatest factors to illness is our emotional and mental state and the industry that “infects” this aspect of man, so to speak is the mainstream media. This politically funded industry simulates a pandemic of epic proportions to become a self-fulfilling prophecy.

At the same time, we have been living in a cancer and disease epidemic for quite some time but the mainstream media NEVER addresses this, such as the rise of autism, the rise of chronic fatigue syndrome, autoimmune diseases, neurological diseases, and various cancers.

So in the end, we must begin to understand the real aspects of pandemics as state-sponsored bioterrorism is being used against us and we must understand the false aspects of pandemics that are socially-engineered as the media’s intention is to make you sick through the art of suggestion and generating a climate of fear.

Let us first discuss aspects of flawed science. In Part 1, we looked at how our current scientific paradigm is based on war and is essentially weaponized science—which is the wrong intention and spirit. Why? Because it is not based on the natural law principles of morality or goodness.

Now, we turn to wrong ideas behind flawed science.

Flawed science is corrupted by the state, by corporations, banking institutions, and money. If money is the incentive, the institution that creates all money from nothing has the power to direct science in any direction... and that direction is to keep man under oppression by his rulers. Money comes from the top-down so the agendas and intentions of the ruling class are what manifests in reality.

Our current flawed scientific paradigm is based in a militarized hierarchy and cult indoctrination where you are put under financial and social pressure to mindlessly believe in certain premises, to never question authority, the official narrative, or even discuss taboo topics. In order to get paid, you must follow orders. Obedience is conflated with honor.

The tactics of fear, shame, threats of group rejection, and psychological coercion are used to manipulate people. Its a cult. The tactics used in the scientific community are exactly the same as the tactics used in military mind-control. Even public schools use these tactics to perpetuate falsehoods.

Flawed science is based on the religion of collectivism, where individual sovereignty and independent thought is suppressed by consensus type thinking. The socially agreed upon values are considered the standard by which to judge everything, a proxy for metaphysical truth.

The reason why there is consensus on flawed science is that these scientists work for authoritarian institutions; they are bought, bribed, their research is biased and their careers are based on funding.

Appeal to consensus and authority are logical fallacies.

Flawed science is based on scientific materialism that divorces rationality from holistic Reason, getting lost in a left-brain maze of complexification. This imbalanced worldview believes that the natural world has no divine order in it and that human reason is beyond the intelligence of our creator and creation and is thus the arbiter of truth. There is no understanding of objective reality, the patterns of nature, and natural laws and how nature is intrinsically oriented towards evolution as an intelligent design.

Until humans seek to understand the natural intelligence of the objective world we will not scientifically evolve.

People falsely believe we are technologically advanced when our technology is killing us, on top of being designed for surveillance and electronic control.

This channel is primarily about philosophy and the Trivium method, of understanding grammar, logic, and rhetoric. It is important for us to ask the simplest of questions to pull back the curtain and expose deception. In order to create a solid philosophical foundation for thought needed to arrive at

objective truth requires examining our most basic underlying assumptions.

The way flawed science works is that it tries to make illogical assumptions and uncritical theories bedrock principles when they are not.

Even on top of a bad foundation, much can be built.... The dark magicians that use illusion to oppress humanity want you to get lost in the details of what is built so that you will not see the corrupt structural foundation that would shatter the entire illusion.

All that comes from a bad foundation is corrupt and can be meaningless.

This is why the context of our understanding must rest in first principles that are rock solid. These are principles of divine origin, mentalism, correspondence, vibration, polarity, gender, rhythm, and causality.

At the closing of part 1, I mentioned how I will be covering a topic not widely discussed and that is something regarding the AIDS pandemic; this ended up being in Part 3 since there is much to cover about the AIDS pandemic and we can draw parallels to the current coronavirus pandemic...All epidemics relate to government public health programs and follow the same blueprint and patterns.

The initial outbreak of AIDS was said to have claimed millions of lives from the African continent and a small percentage of the homosexual population in selected U.S. cities.

AIDS, which stands for acquired immune deficiency syndrome, was the disease labeled for the symptoms of prolonged flu that could develop into tuberculosis, pneumocystis pneumonia, opportunistic infections, and tumors, associated with the cancers of Kaposi sarcoma (skin cancer) and non-Hodgkin's lymphoma (blood cancer).

But couldn't these problems have multiple causes?

From *Inventing the AIDS Virus* (1996):

"AIDS is a syndrome of about thirty diseases, not a disease. It displays no unique combination of diseases in the patient. Clinically, it is identified by the diagnosis of specific diseases known to medical science for decades or centuries." p.209

Now common sense tells us that it would be unwise to place particular symptoms of illness into a single category of disease as well as state that there is only ONE cause to such a range of problems and that that cause can only be natural, but these are the two flawed axioms that our current eugenic medical paradigm is based on, which fits perfectly with the political structure of pandemics that reduces diversity into uniformity... and the individual with collectivism.

The creation of public health started in 1946 with the CDC based in Georgia, now called the Centers for Disease Control and Prevention, and has control over nation's health system connected with Johns Hopkins University School of Hygiene and Public Health. The CDC is primarily focused on quarantine measures and mass immunizations, nicknamed the "medical CIA" because it was about cult-like indoctrination to form an informal surveillance network.

From *Inventing the AIDS VIRUS*:

"As [Alexander] Langmuir [of the US Army and associate of Johns Hopkins] himself described it in 1952, "One of the primary purposes of the Epidemic Intelligence Services of CDC is to recruit and train such a corps of epidemiologists... As a result of their experience, many of these officers may well remain in full-time epidemiology or other public health pursuits at federal, state, or local levels. Some, no doubt, will return to civilian, academic, or clinical practice, but in the event of war they could be returned to active duty with the Public Health Service and assigned to strategic areas to fulfill the functions for which they were trained."

The CDC has nevertheless continued to exploit public trust by transforming seasonal flus and other minor epidemics into monstrous crises and by manufacturing contagious plagues out of noninfectious medical conditions."

"Before long, experts began defining contagious epidemics on the basis of disease "clusters."

Almost any coincidence of two or more closely spaced persons contracting the same disease could

qualify as an incipient epidemic, even if they occurred weeks or months apart.”

“The most recent examples include the premature panics generated by an imminent Hantavirus epidemic in the United States in 1994. The Hantavirus presumably had jumped species, from mice to American Navaho Indians. But after killing just a few, the virus made peace with the Indians and apparently retired to its mouse reservoir. The epidemic failed to materialize.” (p. 136-138)

Both the CDC and the NIH, representing the public health and biomedical research establishments, needed a new war to revitalize themselves. Contagious epidemics had proven the most effective at mobilizing public interest, and the medical and health establishments had spent vast sums of money establishing themselves on microbe-hunting foundations. Yet microbe chasers had exhausted their opportunities with virtually every major disease, from hepatitis to cancer and more. Now they had no clear direction in which to march, no significant diseases to conquer. The virus hunters were heavily armed soldiers without a war to fight. Stated Red Cross official Paul Cumming in 1983, “the CDC increasingly needs a major epidemic to justify its existence.” p. 146

The first AIDS case was reported in 1981 and after five homosexual men showed symptoms of pneumonia that compromised the immune system; it was declared a national pandemic and a highly-organized AIDS public health campaign rolled out.

The agenda was all about creating a specialized illness (a pandemic) with a specialized cause, blamed on a virus, and its specialized anti-viral treatments created by Big Pharma.

Billions of dollars poured into AIDS research as it had earlier poured into cancer, and not a single life was saved by the establishment. Helpful treatments were denied to people when not approved by the FDA and Big Pharma’s deadly treatment like AZT, the protease inhibitor, and chemotherapy murdered many lives. And today billions of tax dollars continue to fund an AIDS vaccine that is nowhere in sight.

Just as Samuel Epstein recognized that the cancer epidemic increased in tandem with the increased funding of the National Cancer Institute and American Cancer Society, the same thing goes for all other epidemics and their funding...with increased AIDS funding we saw more and more people being diagnosed with the alleged HIV-virus.

We must discover the true satanic intention and agenda behind this.

The medical industry made enormous profits and the controllers could carry on their eugenics plan concealed behind public health, recall Kissinger’s report calling for population reduction towards the third world and targeted groups.

In 1985 Dr. Robert Gallo and the French Luc Montagnier discovered the genome for HIV, human immunodeficiency virus and claimed it was the cause of AIDS. Both the American and French labs have connections to the National Cancer Institute and the Centers for Disease Control (CDC).

HIV was a novel retrovirus in a class of novel retroviruses called human T-lymphotropic viruses.

Retroviruses, or the entities we call retroviruses, are viruses that contain an RNA strand, a single-strand of DNA, that can reproduce itself with an enzyme called reverse transcriptase and then integrates into the DNA of the host cell with the integrase enzyme. The host cell then treats the viral DNA as part of its genome.

DNA is a molecule shaped as a double helix containing the biological blueprint and the code to carry out all the cellular functions of living organisms. Retroviruses contain RNA information that is transferred between cells. More on this soon...

The so-called scientific findings of Gallo and Montagnier that HIV causes AIDS was denied peer review and confirmation by the scientific community outside of the militaristic agencies controlling public health. All mainstream science put forth since then builds upon this unquestioned dogma.

In this article, it claims that the virus was detected by the presence of reverse transcriptase, but that enzyme exists in all human cells, other viruses, and exosomes!

Dr. Anthony Fauci, director of the National Institute for Allergy and Infectious Diseases, who is today a lead member of the coronavirus task force played a major role in spreading the HIV-AIDS hypothesis.

Many scientists have come out against the unsubstantiated claims.

The book *Science Fictions: A Scientific Mystery, A Massive Cover-Up and the Dark Legacy of Robert Gallo* goes into the fact that Gallo never detected and isolated a retrovirus in the samples tested.

Even Kary Mullis, Nobel laureate and inventor of the Polymerase Chain Reaction (PCR), a critical technology for studying genetic code fragments, claims that he could not find one scientific paper that proved HIV caused AIDS.

He claimed that the PCR test does not diagnose a virus and yet we are using this test today to diagnose coronavirus.

He has said, "Scientists are doing an awful lot of damage to the world in the name of helping it. I don't mind attacking my own fraternity because I am ashamed of it."

According to Dr. Heinz Ludwig Sanger, Emeritus Professor of Molecular Biology and Virology, there is "no convincing evidence for the existence of HIV. Not even once such a retrovirus has been isolated and purified by the methods of classical virology."

Peter Duesberg Ph.D., author of *Inventing the AIDS virus* and leading expert in the field of retroviruses, who confirmed the existence of retroviruses, worked in the same facility as Gallo and criticized the AIDS hypothesis, which can be found in his 1987 paper.

In 2009 he along with other reputable scientists published a paper titled AIDS since 1984: no evidence for a new viral epidemic—not even in Africa in *Italian Journal of Anatomy and Embryology* and it was withdrawn but then republished passing peer review.

Dr. Bernard Forscher, former editor of the US Proceedings of the National Academy of Sciences claims the HIV hypothesis "is a hoax that became a scam.

Many who tested positive for HIV didn't even show signs of sickness like we see happening with the coronavirus.

In addition to the PCR test being flawed so to are the other tests. The Western blot test, the antibody serology test, and the T-cell count test don't detect a specific HIV viral genome. These tests merely reveal immune and protein activity.

Additionally, it was proven that HIV is not sexually transmitted. What better eugenics operation than to make this false claim.

AIDS fails all epidemiological criteria for infectious disease as well as failing to meet Koch's postulates, the criteria for a virus-causing disease. Predictions made by epidemiologists of how the virus would spread killing people from AIDS have been false.

3. Virus isolation

The virus was isolated from nasopharyngeal and oropharyngeal samples from putative COVID-19 patients. Oropharyngeal samples were diluted with viral transfer medium containing nasopharyngeal swabs and antibiotics (Nystadin, penicillin-streptomycin 1:1 dilution) at 1:4 ratio and incubated for 1 hour at 4° C, before being inoculated onto Vero cells.

This dilution is not isolation.

With false positives and continuous testing the number of COVID-19 cases goes up.

The 2007 book *Virus Mania: How the Medical Industry Continually Invents Epidemics Making*

Many think that the HIV-AIDS virus is a phantom virus, and this is at least partially correct, as we know the AIDS test is flawed and does not detect a virus giving false diagnosis and we know that people are dying from toxicity from many different sources.

In Part 1 we looked at human experimentation by governments. This should be expected because government is based on the immoral premise that some men should rule other men which implies that some men should exploit, oppress, and harm other men to maintain the power differential.

Our assumptions that government is an ethical institution, or could ever be, is the height of human ignorance to our very destruction.

In the 1930s, Rockefeller University financed cancer experiments in Puerto Rico by Dr. Cornelius Rhoads, in which they infected subjects with cancer cells. In a letter, he said that the island "needs is not public health work but a tidal wave to totally exterminate the population," saying, "I have done

my best to further the process of extermination by killing off 8 and transplanting cancer into several more..." Later he was given awards, and he helped establish the U.S. Army Biological Warfare facilities in Maryland, Utah, and Panama.

In the 1940s a US government experiment infected over 5,000 Guatemalans with syphilis and gonorrhea against their will and without their knowledge. Participants included the Rockefeller Foundation, Johns Hopkins, and Bristol Myers, who were given a \$1 billion lawsuit from 800 victims after the discovery of the experiment in 2011. It was dismissed in 2012 under the claim that the US government cannot be held liable for actions committed outside of the US.

Henry Kissinger, Rockefeller collaborator, and member of the Bilderberg Group, Bohemian Club, and Council of Foreign Relations was the secretary of state and national security adviser in the Nixon and Ford administrations. He helped to implement eugenics and depopulation policies.

Before that he helped to find the right Nazis that would be of service to America in the Army Counter-intelligence Corps, as he was the translator and assistant to General Alexander Bolling, revealed in the book Kissinger. Kissinger and Rockefeller developed the Special Studies Project that was compiled in the 1956 book Prospect for America that laid out the plans for the transition of the post-WWII old world order of 13 empires into the New World Order that the United Nations would symbolically represent. September 11th symbolizes the destruction of the old world order and the coronavirus pandemic is the official global launch of the New World Order.

Kissinger played a big part in the Cold War between the so-called superpowers Russia and the U.S. He was the director of deployment of "tactical and strategic nuclear weapons" also using nuclear threat as part of national security. Kissinger was behind Operation Menu, the bombing campaign in Vietnam, Cambodia, and Laos.

Like the book 1984, these ideologies turn speaking the truth into terrorism to maintain cultural hegemony.

In the early 1970s came the war on cancer. The Army's Chemical and Biological Warfare Laboratories also at Fort Detrick became the National Cancer Institute.

In the 1980s the NCI turned to AIDS research. Billions of dollars were given to this military institution and not only were no cures found for cancer and AIDS, but these pandemics spread.

Robert Gallo uses a fallacious appeal to authority and authoritative institutions to defend his AIDS hypothesis.

Because all of these institutions are hierarchical the idea that they could be driven by an elite group for nefarious purposes should not be far fetched.

Human beings are brainwashed into believing that these institutions are intrinsically good, failing to recognize that authority is power and the agenda of power IS the destruction of freedom and the implementation of eugenics and genocide.

Until we understand the nature of government and authority we will become victimized to it.

Soon, we will discuss more about Judy Mikovits, (I apologize for the misspelling in Part 2). She is the co-author of *Plague of Corruption*, who worked directly with these institutions for decades. She discovered that they were creating a product that was causing illness and death. After bringing this to their attention thinking these institutions were good and would take right-action, they instead threw her in jail, destroyed her reputation and career over lies, put her in bankruptcy, and attempted to take her life.

While Big Pharma, the medical institution, and the new-world order-paid epidemiologists, behind the AIDS epidemic, made things worse the pattern has been repeated with the current coronavirus but much much worse as the institutions added to top-down destruction have been the economy, education, and politics among other things.

The two agendas at play were mentioned earlier. At the top, there is a psychopathic or sociopathic agenda perpetrated by the death cult (the ruling class) who feeds off of human suffering.

And in the middle and bottom, there is simply the selfish agenda to maintain or increase one's financial and social standing. The basis for the control of human energy is the monetary system and its fictional creation.

This pyramid represents all institutions connected through authority like governments, corporations, NGOS, philanthropic, secret societies, and think tanks.

In regards to the AIDS topic, the question we need to answer is was there a specific cause for the particular cluster of symptoms, mainly Kaposi sarcoma that we call AIDS because it happened with certain types of individuals, homosexual men in particular U.S. Cities and to the general population in central Africa. Now, we are actually not going to have time to answer that in this part, but we will be laying the groundwork to answering it.

Before we get back into the AIDS topic, we need to discuss theories about viruses and retroviruses. The basis of Big Pharma and Rockefeller's allopathic medicine is germ-theory, which supports viral pandemics and vaccinations.

Recall that retrovirus is the class of viruses that AIDS falls into. While coronavirus is not considered a retrovirus, it contains RNA that can still be inserted into a DNA genome. We should ask ourselves, what is the purpose of this transfer of genetic material?

We use the term "viruses" and "retroviruses" loosely because public health theories rest on flawed science, containing many contradictions in their descriptions of these cellular fragments that reveal a lack of understanding. Better theories, more aligned to Natural Law, have been marginalized and rejected that deserve our time and attention.

In the eugenics context, we understand that false knowledge is deliberate as they serve specific power agendas. We live in the scientific dark ages keeping us afraid of nature and ignorant of our own biological processes.

What does mainstream science have to say about viruses?

How did we get from a non-living entity with genetic material to a genetic parasite that makes copies of itself in order to destroy the host organism? There is no logical bridge or provided evidence for this assertion as this activity has NEVER been observed under a microscope.

Another problem in this video is that it depicts a virus replicating itself to infect the host, but the virus is not capable of reproduction and is not an organism at all. Viral genetic information is ONLY replicated when cells replicate after integrating this viral information. When the cells die the virus ceases to exist.

At the end of the 19th century, the field of microbiology created the dogma called germ-theory that microorganisms were the single cause of disease and cancer, going by the formula that every disease has one specific germ that caused it. This is the theory that underlies the pharmaceutical industry so that they can give you a false cure or vaccine for each germ.

Later we will be looking at how this theory underlies nanotechnology in medicine discussing the transhumanist agenda.

In the early 1900s microbiologists attempted to make bacteria the cause of illness. Louis Pasteur,

the father of germ-theory, falsely believed that healthy tissues inside the body exist in a sterile germ-free environment, but any experiments putting animals into a sterile environment killed them. Sterilized mice would still produce bacteria.

Pasteur and Robert Koch could not prove that bacteria is the cause of illness and mainstream science was forced to admit the importance of bacteria within our bodies, especially in our digestive tract.

Eco-systems *depend* on bacteria and bacteria do not decompose the living or attack healthy cells but is nature's recyclers as bacteria breaks down dead matter.

In the Natural Law context, it is an important part of the life cycle. As Antoine Bechamp said, "nothing is the prey of death; all things are the prey of life."

When bacteria as the microbe enemy failed Rockefeller funded science turned to viruses. While bacterium is a unicellular micro-organism that can reproduce, usually rod-shaped and typically a few micrometers, a virus is not necessarily a micro-organism as it cannot reproduce and is often spherical and 5 to 300 nanometers.

Let's look at the experiments that so-called proved (retro)viruses where bad as this agenda was driven by surprise surprise the Rockefeller Institute for Medical Research.

At the Rockefeller Institute, the first retrovirus was supposedly discovered in 1911 by Peyton Rous, who studied at Johns Hopkins.

In the experiment, Rous took a tissue sample from the sarcoma tumor of a chicken with leukemia, filtered out tumor cells and bacteria, and then injected the solution into healthy chickens who then got a sarcoma tumor. The conclusion was that the invisible avian/leukosis virus was in the injected solution and caused the disease. We can see what a jump in thinking this is.

The first question is what was exactly filtered out and what remained in the solution, we do not know. Many scientists of Rous's era argued that the filtrate was not cell-free. Due to the rejection of his experiments, Rous terminated his research as it never went any further and he did not isolate any virus... but after 55 years all of sudden he won the Nobel Prize for his discovery. Within 10 years other novel retroviruses like the family of AIDS would appear on the scene and we shall see that this is not coincidental.

Let's assume Rous' experiment is repeatable, giving it the benefit of the doubt even though it lacked peer review. This is the most common experiment in germ-theory: injecting the diseased tissue into another animal to cause disease and then saying the bacterial or viral content of that injection is the cause of disease in the first animal.

We have no clue what was in the sample post-filtration as particles the size of 200 nanometers would not only be viruses but smaller cell particles, cellular wastes, and dead cell debris.

Real scientists have found that viruses are attempting to eliminate dead tissue and waste caused by environmental toxicity.

Injecting dead cell waste of one animal into another animal would be carcinogenic for obvious reasons and could contain toxic material by virtue that it is waste.

Even if we inject health cells debris of one animal into another that would still potentially cause illness because it is a foreign substance that would activate the immune system. In attempts to remove the substance from the body, a tumor could form.

Because an injection into the bloodstream doesn't happen in nature the animal's more vulnerable.

Putting biological material where it doesn't belong does not prove that certain biological material is harmful to its source.

Why do the animals in the experiment get the same illness?

While left-brain science can only perceive one type of particle causing an illness, holistically, we should consider morphic resonance at play and the empathic resonating physical systems between living beings that could potentially share an illness through injection as a holographic response of shared resonance.

What these experiments showed was how to inflict illness, not discover the cause of the original illness.

And don't worry, I'm going to address the animal issue soon—as that immorality alone is enough to end this pseudo-scientific pursuit. The false axiom: *the ends justify the means* will never lead us to true scientific knowledge... we will explore more about these unethical and irrational experiments as well as Koch's flawed postulates in the following parts of this series.

Funded to be what he calls a “microbe-chaser,” Duesberg discovered a cancer gene in a retrovirus and became a praised retro-virologist but realized that this oncogene was harmless to the animal host.

His career and reputation were harmed when he didn't buy into the AIDS narrative.

In the book he states:

“Virtually all retroviruses proved to be benign passenger viruses in animals outside the laboratory.

Even the very few oncogenic retroviruses—those endowed with cancer genes—hardly play a role as carcinogens for two reasons. First, viral cancer genes accidentally acquired are never kept by retroviruses after they are generated because they are entirely useless to the virus—just like a genetic cuckoo's egg. Second, even if a rare oncogenic retrovirus infects an immunocompetent animal, a small tumor will appear within days after the infection, only to disappear again as the animal develops antiviral immunity. Antiviral immunity kills both the virus and all virus-infected cells. As a result, retroviral cancers are extremely rare and very survivable tumors in wild animals. Their statistical relevance as carcinogens is negligible.” p. 120 • INVENTING THE AIDS VIRUS

According to Duesberg, the belief that tumors are caused by endogenous retroviruses is baseless as some retroviruses were found near tumors because they were helping to eliminate the tumor, which is why we find them on tumorous tissue.

There is no reason to assume that particular cellular activity and micro-particles CAUSED something merely due to their presence in an infection.

Duesberg has said that finding a microbe is not enough to convict it of disease.

From Fear of the Invisible:

“I had earlier learnt that viruses invade cells in order to reproduce, and that cells are the victims of this process. I also learnt that HIV was a retrovirus that hijacked cells. But I now realized there was an entirely different way to see the process. Biology, a science that unlike virology, has no focus on illness, has taught me that no virus exists that is not made by a cell, that these are produced by all healthy cells, whether of plants, fungi, birds, fish or animals, and that cells apparently consider retroviruses so harmless that they will trustingly incorporate codes brought by them into their very genomes, into the protected centres of their being.” p.231

When the electron microscope was created in the early 1930s viruses were observed. However the sampling procedures would kill the tissue, so they were observing static

The flawed scientific establishment assumes that certain particles, like viruses, found in diseased tissue or the blood are the culprit for diseases, but how do we know the difference between the immune response, cellular waste, and the original toxic element? How do we differentiate cause from effect, the perpetrator from the symptom attempting to heal?

Complex theories are explored when we cannot see the movements play out as sampling procedures kill the specimen.

We may not be able to extract the causal element from diseased tissue as we are looking at a chain of events such as chemical reactions and bodily processes responding to toxins; this can obfuscate cause to some degree. Also, nonlethal causes require multiple causes—including microwave radiation which cannot be detected as a particle invader. Causation also includes mind and emotions.

When we see a person blowing their nose from sickness, we do not see the mucus as the cause of sickness but its symptom.

Could viruses actually be a response from the body to eliminate waste? Many researchers and holistic practitioners think so.

Germ Theory and Conventional Medicine

At the turn of the 20th century, as Howard Berliner (1985) has documented, straight germ theory (germ x causes disease y) became established as the core of “scientific medicine” in American allopathic medical education. At the time, the major rivalry in American medicine was between allopaths (approximately 60% of medical practitioners) and homeopaths (approximately 30%, the balance being eclectics and physio-medicalists).

Once the substantial resources of the Rockefeller philanthropies were put behind scientific medical education based on germ theory—with the full consent of the AMA—American medicine became synonymous with the germ theory. This, the Flexner Report (1910), and medical research devoted to finding pharmaceuticals to defeat germs to “cure” disease, were all funded by Rockefeller philanthropies and lead to what is considered to be the dominant paradigm in American medicine. 4

As Berliner documents, this was largely the result of a determination to put the Rockefeller philanthropic resources behind this concept of “scientific medicine” not, at the time, any clear clinical superiority on the part of the allopathic philosophy. As of the period in which this took place, largely 1900 to 1920, there was no clinical validation for scientific medicine in terms of the discovery of specific pharmaceuticals of demonstrated efficacy.

To summarize: According to Bechamp’s terrain theory, the alternative to Pastuer’s germ-theory, the environmental toxicity (without and within the body), the terrain, is what causes sickness and micro-organisms are the immune response of the body to clean up the terrain.

Claude Bernard said, “The terrain is everything; the germ is nothing.”

Bechamp found that germs: bacteria, viruses, and microbes do not attack the body from without but are produced by the body from within as the effect, not the cause.

These microbes, which he called “microzymas” are the smallest units of life and are part of our internal eco-system coming from our red blood cells.

In *The Blood and Its Third Anatomical Element*, Bechamp states:

“The microzyma is at the beginning and at the end of all organization. It is the fundamental anatomical element whereby the cellules, the tissues, the organs, the whole of an organism are constituted living. ... In a state of health the microzymas act harmoniously and our life is, in every meaning of the word, a regular fermentation. In the condition of disease, the microzymas do not act harmoniously, the fermentation is disturbed, the microzymas have either changed their function or are placed in an abnormal situation by some modification of the medium” (2).

While germ theory is based on monomorphism, the belief that all species are fixed, Bechamp saw that pleomorphism was more true to reality and that bacteria and viruses are different phases of the same micro-organisms changing as a response to a changing terrain.

This makes sense with Natural Law and the concept of equilibrium. Some scientists call this homeostasis. In the state of disequilibrium, for example too much acidity, there would be a bodily

response attempting to reverse the condition and return it to equilibrium.

Developmental stages are essential to understand when examining the human body because the body is never NOT in a state of change.

Cycles of micro-organisms make sense as “nature’s recyclers” must have a variety of forms to deal with a variety of conditions.

The pleomorphic view of Bechamp was evidenced by other scientists like the dark field microscopy work of Gunther Enderlein (1872-1968) and the work of Royal Rife and his universal microscope.

In the 1930s Rife created this microscope using a series of prisms and monochromatic light beam with a magnification of 60,000 times that could show the specimen by resonating at its frequency without killing or interfering with it.

The pleomorphic cycle was also confirmed by Gatson Naessens and his high-resolution Somatoscope.

Naessen went very in-depth in describing the cycle in which the first three stages are all found in the healthy blood of all humans.

Naessens called the basic micro-organisms somatid, which Enderlein called protit, and Bechamp called microzyma. These are different names for the fundamental microbe that is always present in the body, under the classification of all endogenous micro-organisms. It is possible that what some believe to be a virus is one of these types of microbes.

Our corrupt medical institution uses the term “viruses” which in Latin mean “poison” thus using language to propagate a negative bias on this micro-organism.

Today, these microscopes mentioned aren’t used in the suppression of true science. The electron microscope is used and while it has a higher magnification, it kills and changes the sample with fixing and staining creating artifacts.

All three of these scientists were destroyed by the state-sponsored medical establishment and the cure for cancer that Rife discovered was also suppressed.

An article from the *International Journal of Vaccines and Vaccination* by Robert O Young entitled *Second Thoughts about Viruses, Vaccines, and the HIV/AIDS Hypothesis* states:

“There is a common biological basis for the pleomorphic cycle and its increasing complexity of organization: More complex forms evolve inherently upon the death of an organism for the purpose of recycling its anatomical and chemical structures in the carbon cycle. The process of rapid evolution (which is reversible) is an essential life process which, beyond the repair stage, is necessary to return a dead organism to the earth. The second and third-stage microforms degenerate the body’s vital substances and tissues via putrefaction (bacteria) and fermentation (yeast and fungus). Fermentation results in acid waste products, which further break down tissue. Disease symptoms, then, especially the degenerative type, are not produced by viruses, but manifest as chemical decomposition, or attempted recycling via fermentation and acid toxins, but with “host” survival processes still operable. Obviously, certain other factors may play important roles in producing symptoms, such as heavy metal toxicity, or state of mind, for example. Some of the body’s survival methods also produce symptoms commonly called diseases. An example is eczema, an emergency expulsion of acid toxins via the skin.”

The aforementioned causal (alarming) situation, or modification of the medium, is chronic acidification (pH imbalance) and oxygen deprivation in the blood and tissues due to acid-forming foods, adverse lifestyle, emotional stress, and environmental stress. This is not oversimplification. Acidification/hypoxia biochemically signals a dead host to the microzymas, while creating collapsed areas (dead zones) of the colloidal system in the intercellular fluid, and it is the primary physiological disease condition out of which the symptoms commonly called specific diseases arise.

Thus, we distinguish between this disease condition and its consequent symptoms, which include both the morbidly evolved microzymas and the physiological signs commonly, thought of as specific diseases. As they develop, microforms (bacteria, yeast, fungus and mold) are actually scavenging

forms of the microzyma, developed when disease in the cell life requires tissue to be broken up. These upper development forms are the ones easily visible in the blood before physical symptoms arise. They disappear (devolve) when the recycling task is complete, once again becoming microzymas of the earth and/or air.”

In the better theory of viruses, viruses are a phase of micro-organism that becomes necessary to dissolve dead and dying tissue that has become so toxic that earlier phase of micro-organisms such as bacteria cannot feed and eliminate the tissue, wastes, and cellular debris without being poisoned to death.

Micro-organisms are opportunistic because they manifest only when the opportunity (i.e. faulty terrain) presents itself.

A cold is usually bacterial while the flu viral because the flu-virus is cleansing what couldn't be cleansed with bacteria.

Coronavirus is a respiratory virus manufactured by cells in the lungs and respiratory areas to cleanse themselves of systemic toxicity. This toxicity comes from the pollution in the environment like factory (petroleum) wastes, burning plastics, and heavy metals from chemtrails.

The coronavirus epidemic allegedly began in Wuhan China and we should keep in mind that China has had air toxicity issues in burning its garbage using incineration plants in residential and commercial living areas.

Just last year, thousands protested to stop the construction of a plant being built near Wuhan.

Some think of viruses as solvents for toxic cells. Dr. Barre Lando perceives viruses as cell fragments interacting with DNA and RNA, initiating self-correcting mechanisms like the release of surfactants to dissolve diseased tissue.

Let's look more at the genetic aspects of viruses.

Barbara McClintock, a Ph.D. scientist, who was marginalized from the scientific community for her holistic insights but still managed to win the Noble Prize, saw that our cellular functions are extremely intelligent and create a network of communication between cells through genetic changes.

She discovered *transposons*, which have been called jumping genes and “molecular-sized engineers” in which DNA segments can move from one place to another through a cut paste mechanism.

The transposon mechanism underlies retroviruses or genetic microbes and cell-based particles like exosomes that can send and receive messages.

McClintock's research countered the belief that viruses attack a victim cell, seeing them as important for communication between cells in response to environmental stress. She discovered that healing occurs in the restructuring of the genome and genetic repair.

This article discusses the research of Nels Elde ph.D., who uncovered that viral elements from human DNA came from our ancestors, thousands of years ago and our essential for our immune system.

The discovery of reverse transcriptase reinforced McClintock's findings. Bad science tried to make this enzyme responsible for cancer, but it part of cells.

We used to only perceive cellular DNA as transcribing into RNA to make proteins, but never going from RNA into DNA, as an RNA sequence being inserted into a DNA sequence. However, living communication in biological systems requires the capacity to both send AND receive messages, as there is an inherent bi-directional mechanism to the living cosmos.

Scientism only perceives things in one way and so misperceives this backward process of reverse transcriptase as harmful.

Just as some scientists have called viruses exosomes, some are now calling retroviruses *transposons*. This article entitled *The Human Genome is Full of Viruses* discusses the rhythmic cycle of viruses that don't have a body during their dormant phase... the author describes it as "these disembodied viruses are called transposable elements, or transposons. True viruses have a body made from proteins, but transposons are mobile genetic elements – sequences of DNA that physically move in and out of genomes. Eight percent of the human genome is made up of endogenous retroviruses but nearly 50% of the human genome is made of transposons! Humans are basically just big piles of vial-like sequences."

Now, "a pile of viral-like sequences" sounds dull, but this biological network of communication is nothing less than magnificent. Not only do our cells have life cycles, but our DNA is constantly altering in its movement through time.

Visual artists attempt to capture aspects of biological beauty in an abstract and holistic way, elucidating mathematical precision of movement, fields of morphic resonance, and the state of constant flux with a style of art called "Morphogenesis."

From *Second Thoughts About Viruses*:

"It is known that normal cell activity includes genetic repair. Both enzymes and proteins must be involved. What is the mechanism? Viruses are organized around DNA or RNA, not both. Thus, they are quite probably intended to repair genetic molecules or other structures, and show up with disease symptoms because the body needs them. Since viruses require a living cell/host for reproduction, how do we know that the scenario is not set in motion for a purpose by the cell (i.e., its microzymas), rather than being the result of invasion? Because disease (disturbance of balance in the organism) is so prevalent, especially that which has not yet become indicated by common symptoms, repair proteins may be frequently or constantly present. A toxified cell may easily suffer localized damage to the genome. Since most observers are not even aware of microzymian principle, much less understand or even consider it, and since monomorphism stresses invasion, these protein complexes are regarded as foreign and disease is attributed to them."

From *Fear of the Invisible*:

"When confronted by a toxin, such as from petrochemical fumes, cells work assiduously to protect themselves by adjusting their DNA. They thus help us survive the many toxins we encounter in modern life." p.243

"Another biologist Dr. Mae-Wan Ho, the founder of the Institute of Science in Society said, "I see all nature developing and evolving, with every organism participating, constantly creating and recreating itself anew."

(Professor James A.) Shapiro wrote: 'The expectation of its pioneers was that molecular biology would confirm the reductionist mechanical view of life. However, the actual result of molecular studies of heredity, cell biology and multicellular development has been to reveal a realm of sensitivity, communication, computation and indescribable complexity.' He also said: 'The conceptual changes in biology (since the work of McClintock was recognized) are comparable in magnitude to the transition from classical physics to relativistic and quantum physics. p.244

(Now while relativistic/quantum physics cannot be regarded as holistic science, it pushed materialistic science to its outer limits making the old paradigm obsolete. A paradigm shift in consciousness is required for the advent of holistic science.)

McClintock provided some of the groundwork for epi-genetics which shows how our environment and consciousness have an effect on our genes—which can no longer be considered immutable and static... this follows the Hermetic principle of vibration and motion and philosophical principle of matter and form.

Dr. Bruce Lipton has been a pioneer in the field of epi-genetics.

Besides the theory that viruses are a phase of micro-organism is the theory they are exosomes.

Exosomes are small vesicles created within the cell that are released by the cell into extracellular space. They often contain RNA messages to deliver to other cells.

From Fear of the Invisible:

"It now seems that we may have misconceived the virus; that most of them could well be simply inert messages in envelopes carried from cell to cell. In the last ten years scientists have begun to call them 'exosomes', 'particles that leave the body' of the cell, removing the inference that the 'virus carries: of them being dangerous by nature. Distinguishing the healthy particle from the pathogenic is now an enormous problem for the virologist. for it has been discovered that our cells make them all in the same way, in the very same place. It also seems we cannot stop this process without risking severely damaging our cells."

"In 2007 it was described how 'cells send RNA messages to each other by packing these into exosomes' and how exosomes can carry a 'large amounts of RNA' from one cell to another - up to 1,300 different mRNAs! (p.237)

Many scientists think that the HIV virus is an exosome. The book says:

"HIV specialists have now named HIV as a 'viral exosome.' The Journal of Cell Biology reported in 2003: 'Hildreth now proposes that: "the virus is fully an exosome in every sense of the word."' Then, in a 2007 paper, they advanced the 'hypothesis that HIV and other retroviruses are generated by a normal non-viral way of exosome biogenesis' and added; 'We proposed that retroviruses are at their most fundamental level. Exosomes. (The result of this has been astonishingly the authorisation of a course of drugs designed to stop our cells making exosomes; no matter how important they might be to us, in fear that the cells might thus make HIV.)" (p.239)

Today some think that the coronavirus is an exosome. Dr. Andrew Kaufman gives a great explanation of this showing the similarities in their images and in the PCR testing.

The reason why retroviruses and exosomes are more seen with sick individuals is that the cellular mechanism of repair requires more communication between the cells. In a stressful condition, more genetic alteration has to be done to adapt to the environment.

Electron microscopy shows how these messenger carriers can move from one cell to another through a cell-created nanotube (image).

Again, we must use the term retroviruses cautiously since they could represent various entities like communicable micro-organisms, transposons, cell genes, cellular fragments, messenger RNA, exosomes, or any microscopic particle produced by the cell that can deliver information.

In this time of dark age science, we can't even properly identify things because it is being deliberately perverted by the powers that shouldn't be, but hopefully, I have offered you better explanations from other scientists, doctors, and researchers I have found.

We think of computer viruses as our computer being infected with bad information, but getting software updates is your computer incorporating new information, hopefully, beneficial information—which can be thought of as a positive virus.

While "virus" means something negative, we are discussing an essential archetype here, of the messenger. This archetype is basis for hermeticism and Hermes Trismegistus, who cracked the verbal code of the cosmos realizing Law of Mind and has shared with us the message of perennial wisdom. We understand the cosmos through information and more accurately mental knowledge. Likewise, our cells understand their environment through DNA communications.

It is important to note that we are not even scratching the surface of cellular communication.

From Fear of the Unknown:

Cells do not only communicate by means of exosomes or viruses; they also do so by movement, electric currents, chemical emissions (smells), photons and magnetic fields. They can send light signals to each other to make near instantaneous communications. The water within the cell is also used. Rich in salts, it preserves information, and, as it flows within the cell, it generates the electric current needed for the signals sent through the nerves. (p.245)

Because our DNA has viral genomes, this is another reason why testing RNA fragments in PCR for particular retroviruses may be inconclusive and in error when cellular components are not separated from viral components leaving DNA fragments from various sources.

There are two kinds of viruses/retroviruses, endogenous and exogenous, that which is naturally where it belongs and viruses that are in the wrong place—coming from a different living source. This includes xenotropic viruses from other animals, from other humans, or genetically modified viruses.

We are told that particular infectious pathogenic viruses come from animals like the hantavirus from mice, swine flu from pigs, the coronavirus from bats, and HIV from monkeys.

This would imply that these viruses come from their bodies, that they are endogenous to those species. That would cohere with what we have learned in that viruses come from cells of living beings. But if the viruses of these animals got inside humans they would be considered exogenous.

The important question becomes how can one become “infected” with a virus from another being or animal species? How do viruses from one animal get inside another? How do viruses spread?

While germ theory and viral sciences claim that people can inhale external viruses there hasn’t been actual evidence to this. The idea that viruses exist singularly floating in the air or water or saliva droplets and are infectious or contagious, entering into in through the mouth, nose, and skin is nothing more than belief.

If the vaccine theory states that viruses are spread through the air then why aren’t we administered the vaccine through the air, through *aerosolization*? Shouldn’t we be given the virus in the way that they say we would contract the virus? Otherwise, we could be introducing a more harmful element to the so-called transmission.

If we never get viruses straight into the bloodstream then using injections to create immunity lacks rational basis as there would be different immune responses. The immune response of the skin and mucus membrane is different than that of the response of the blood.

To anyone with a drop of common sense, there would be far more harm when given a virus directly into the blood than through the air—as the body’s defenses are much much stronger to toxins in the air. You can fend off mercury in the air much more than mercury in the bloodstream.

The fact that vaccine theory rests on viral injections, an unnatural way to get a virus, totally destroys vaccine theory, which is supposed to be based on mimicking an illness.

Do you really think scientific experiments have been done to show how much aerolized air of a virus creates infection to measure how much virus is in the vaccine they give you?

The reason why we are told to wear masks and socially distance is because this particular coronavirus is supposedly airborne and can travel 5 meters. But there is no evidence for this or evidence for the infectious nature of any virus. It is based on belief and flawed science.

In this paper entitled: *Saliva is Non-Negligible Factor in the Spread of COVID- 19* it makes a lot of assertions without any hard proof. <https://onlinelibrary.wiley.com/doi/full/10.1111/omi.12289>

It says that because “SARS-CoV-2 has been detected in saliva samples,” this makes “saliva a potential transmission route for COVID-19.” This is a non-sequitur.

It states that the “investigation of the biological functions of saliva on the behavior of viruses... suggest the transmission of virus.”

In the conclusion, its states that “saliva...acts as a potential route for the spread of disease.” This is based on flawed virus theory not evidence.

On July 21, 2020 they finally did a study showing infectiousness, which is *after* the mandating of many state policies that are based on this theory. It is entitled “The Infectious Nature of Patient-Generated SARS-CoV-2 Aerosol” and has not been peer-reviewed. It claims that virus taken from

the air was grown on Vero cell line proven to be infectiousness simply because more RNA was detected through PCR after five days of the cell line being inoculated.

Let's assume that more virus was indeed detected in the culture, even though we know the flaws of this test—which would be amplified with all the problems in collecting aerosol samples.

Cell culture is kept alive artificially by fluids that are toxic and damage cellular activity. In this way, the cell line is dying and cannot be compared to the healthy living cells in one's body.

It would be logical that these cells lines and their unhealthy conditions would produce micro-organisms which are produced when there is cellular decay so you would test for more virus.

The idea that viruses multiply in the petri dish doesn't make sense because viruses cannot multiply by themselves—they only come from cells.

Viruses do not infect healthy cells. Take, for example, the retrovirus with genetic information that is inserted in the DNA of a cell. This could only happen if it came from the cell, otherwise, it would be identified as a foreign invader.

To reiterate from earlier viruses dissolve dead cells and waste when the terrain is too toxic, which is why they are seen with the flu. Viruses and micro-organisms are the body's natural detoxification system.

"Viral facts; Viruses cannot enter through the skin or eyes. Such vectors do not work because the mucus membranes and the immune system discard small amounts of foreign proteins such as viruses.

Viruses cannot enter through wounds because we bleed outwardly, not inwardly."

There are 320,000 viral strains inherent to the human body, and each cell contains the viral protein makeup to manufacture each strain when the body calls for it.

Coughing, sneezing, and spitting is not a vector for the transmission of viruses. Saliva and mucus membranes break down any such particles.

Skin is not a vector either because viruses cannot cross dead skin layers.

Viruses are a result of internal toxicity caused by the environment."

Our eugenics-medical establishment based on bad science wants you to believe that viruses and retroviruses are naturally deadly and infectious and that nature is the greatest bio-terrorist. This covers up the true origin to many of our health problems that come from man's immoral actions across many fronts; this also supports the false narrative that Big pharma is your salvation, which provides harmful solutions.

While poisons and toxins exist in nature and we can become harmed by them, take for example eating a plant, like hemlock, that is poisonous, this doesn't mean that nature is cruel but that we need to have knowledge of nature so that we can take right-action, like not eat poisonous plants. Polarity exists, poisonous plants have a purpose in evolutionary expression—like self-defense, and there is a right and wrong use to the natural products of the world.

When toxic compounds in nature are in their proper place, these agents serve a natural function but when they are not in their proper place, for example, isolated and modified, they can potentially be used as bioweapons.

It was clearly the intention of the US bioweapons lab to isolate, extract, and tamper with certain biological chemicals and micro-organisms in order to create harm.

Taking aspects of nature and making them more deadly is not nature's fault but our fault and our responsibility. Putting biological materials where they don't belong or genetically engineering them has negative consequences, not because of nature's immorality but our immorality.

These studies are called "gain of function" and involve the task of making viruses deadly and contagious.

In 2014, this was recognized as wrong and legally banned in 2014. But just as bioweapons research didn't end with Nixon's ban, neither did these studies.

Anthony Fauci continued these studies at the Wuhan Institute after being in the North Carolina labs, with the task of making bat coronaviruses infectious to humans.

In 2017, the ban was lifted so that these studies could be public.

Fauci denies that the Wuhan lab had anything to do with this current pandemic, despite the fact that the lab was only 20 miles away from the seafood market where the virus allegedly infected people, and he claims that COVID-19 naturally evolved to jump species.

Now that we know natural viruses aren't contagious, there is no validity to the theory that animal viruses infect us. There is no cross-species of viruses as the RNA and DNA of the animal are not compatible with human genome.

As we have looked at, natural genetic engineering takes place within our bodies to adapt to our environments.

Sadly, hijacking nature's ways for nefarious purposes has become the basis for the field of molecular biology and man-made genetic engineering.

If retroviruses or what we call retroviruses are important cellular messengers, the archetypal Mercury/Hermes at the molecular level so to speak, then the attempt to weaponize this natural process could be an attempt to use foreign biological material to send erroneous messages to our cells for deadly purposes or genetic modification purposes.

An aspect of this gain of function task would be about creating genetic material and putting into our bodies in a way that could disrupt and distort our human cellular communication system enough to genetically change us for the worse.

Is this even possible? The fact that foreign substances are not recognized by the body appears to destroy the possibility of communicability between our DNA and foreign RNA or foreign DNA.

Nonetheless, putting foreign substances into the body in a way that is difficult to expel could create an immune response that could be deadly, making it a bioweapon in that regard.

But later on, we will look at the alteration of our DNA and the additional technologies required for that endeavor as the darker side of eugenics when combined with transhumanism.
